1. Copyright; Permitted Uses

- 1.1 The Information is the property of The LA Times-Washington Post News Syndicate, The New York Times News Service, and Press Associaton, Inc., and is protected by applicable copyright law.
- 1.2 The Organization represents that it will use the Information only to pursue research objectives. The Organization shall not, and shall not permit any of its Authorized Users (as hereafter defined) to publish, retransmit, redistribute, sell, commercially exploit or otherwise reproduce any or all of the Information in any format to anyone, except as expressly provided in this Agreement.

2. Access to the Information by Authorized Users

- 2.1 The Organization may only grant access to the Information to individuals working under its control, i.e., its own members, consultants to the Organization, or individuals providing services to the Organization who are specifically authorized by the Organization for such purposes (an Authorized User).
- 2.2 An Authorized User may be allowed access to the Information only after being informed of the provisions of
